RULES AND REGULATIONS

- 1) We ask that floats only be a maximum of 14ft in width to ensure safe travel throughout the parade route. Some streets are very narrow and congested so this will ensure the safety of all participants.
- 2) All groups should be participating in our "Holiday/Winter" theme. Groups who do not a festive winter theme will ask to not participate in the event.
- 3) Like all community events, we ask participants to refrain from campaigning or demonstrating political messaging in any displays or handouts.
- 4) All participants should be dressed for the elements. Mother Nature has provided some pretty cold parades in the past and the event takes over an hour to complete the entire parade route.
- 5) All float participants must be safely positioned on floats. Participants should not be sitting off the side of any moving vehicle.
- 6) Candy should not be thrown from any moving vehicles to ensure the safety of participants and spectators.
- 7) The only Santa Claus allowed in the parade is on the Fire Truck at the end of the parade. No other Santa's are allowed.
- 8) All vehicles participating in the parade must be registered and safe for operation.
